POWERED GOLF CART POLICY AND RELEASE OF LIABILITY**

1. ALL powered cart in use during an event must be registered. Registration will be proven through a Single Event Credential Sticker which must be PERMANENTLY affixed to the approved powered cart on the front driver's side in the lower corner of the windshield or front hood. Each Single Event Credential will possess a control number plainly visible to identify the person or company who as registered the powered cart.
2. Company shall provide proof of general liability insurance (or automobile liability in the event the golf cart being registered is street legal) with limits of no less than \$1 million dollars per occurrence, including all the Additional Insured Parties (as defined in Section 9 hereunder) as additional insureds, and must be supplied along with this completed form and such insurance policies shall be active throughout the event. Certificate of insurance shall state that such insurance is primary and non-contributory to any other insurance that may be available to an Additional Insured Party and that a Waiver of Subrogation applies in favor of the Additional Insured Parties in accordance with the Certificate of Insurance Requirements for Americrown Golf Cart Rentals, attached hereto. Insurance coverage shall apply to the fullest extent of Company's insurance policy limits or to the extent allowed by law, whichever is greater.
3. The use of equipment by Company, as authorized herein, will be restricted to business use only.
4. Equipment will be driven by Company in a safe, slow, and careful manner and shall at no time exceed any posted or designated speed limit. At all times drivers will yield to pedestrians. Anyone observed driving in a careless or unsafe manner, including and without limitation, in violation of any provision of the powered cart policy and release of liability, will be removed from the property and have their Single Event Credential revoked. The Company agrees to be responsible for compliance with any applicable laws, government regulations, and facility rules in the use of the Equipment
5. Equipment must be driven by a licensed driver over the age of eighteen (18), unless applicable state law requires a higher age limit (by way of example, Alabama requires operators to be at least nineteen (19) years old). The number of passengers may not exceed the manufacturers designed and installed seating capacity and/or capacity indicated on the Single Event Credential Sticker. All passengers must be remain seated during Equipment operation.
6. Alcoholic beverages are not permitted in any Equipment, except for delivery purposes only. No alcohol is to be consumed by any driver and/or passenger while the Equipment is in use, and no driver shall operate any Equipment while under the influence of alcohol.
7. Only Equipment equipped with factory installed (or equivalent) front headlights and rear running lights may be operated by Company after daylight hours.
8. Equipment usage will not be allowed in restricted areas or during times not authorized by racetrack management. No golf carts shall be operated on public roads.
9. Company hereby agrees to release, hold harmless, indemnify and defend Americrown Service, LLC, its parents, subsidiaries, limited liability and affiliate companies, and their respective members, shareholders, officers, directors, agents, employees, sponsors, trustees, receivers, successors, subcontractors and assigns, the City of Homestead, the Daytona Beach Racing and Recreational Facilities District, City of Daytona Beach, and County of Volusia (collectively the "Additional Insured Parties") from liability or damages including third party claims ("Losses") arising directly as a result of the gross negligence, willful misconduct, or violation of applicable law by Company, its employees, agents, and/or representatives' use of the Equipment as set forth in this Agreement. Company's obligations hereunder to release, hold harmless, indemnify and defend the Additional Insured Parties shall not extend to claims, including third party claims or Losses, arising directly as a result of the Additional Insured Parties' gross negligence, willful misconduct or violation of law of an Additional Insured Party in its provision of Equipment to Company or any of its obligations to Company as set forth in this Agreement. In no event will either party be liable for any indirect, incidental, special, consequential, exemplary or reliance damages (including lost or anticipated revenues or profits) arising out of this Agreement.
10. Company shall have no right to sell, assign, delegate or in any way dispose of or encumber any of the rights or duties granted under this Agreement. Any such attempt shall be deemed to be null and void and shall be considered a default under this Agreement, entitling Americrown Service, LLC, at its sole discretion, to terminate the Agreement and to seek any and all other legal or equitable remedies it may be entitled to pursue under this Agreement or under the laws of the state where the facility is located. Further, any change in control (whether by merger, asset sale, stock purchase or other assignment or operation by law) shall for the purposes of this Agreement be deemed an assignment of the rights and obligations contained herein and shall require the prior written approval of Americrown Service, LLC, which shall not be unreasonably withheld.

I have read, understand and accept all the terms of use for a powered golf cart. Failure to comply with these terms may result in revocation of the Annual Registration Credential, the golf cart being impounded and/or forfeiture of golf cart privileges in Americrown Service, LLC's sole discretion. The undersigned has the requisite authority to bind the Company to the obligations herein. My signature below signifies full and total acceptance of these terms and agreement to comply.

OPERATING GOLF CART GUIDELINES

In an effort to promote a positive and memorable experience for our corporate partners, sponsors, and most importantly our race fans, Americrown Service, LLC is requesting all operators of golf carts or other specialized vehicles (collectively "Vehicles") read and understand guidelines outlined below. Remember at all times to yield to pedestrians and whenever possible, please choose to walk.

- Use of Vehicles is for BUSINESS USE ONLY
- Operating a Vehicle requires proper permits, documentation and approval by Americrown.
- Vehicles may not operate in No Drive Zones during restricted times and designated areas as determined by the racetrack facility authorities. (Excludes Emergency Vehicles)
- No more than two (2) passengers per seat row. The number of passengers may not exceed the number listed on the Permit.
- Keep your entire body and your passenger's bodies inside the Vehicle at all times and remember to hold on while in motion.
- ALL OCCUPANTS MUST BE SEATED BEFORE KEY IS TURNED TO THE "ON" POSITION.
- Whenever the driver is not seated in the Vehicle, SET THE PARKING BRAKE and remove the TURN KEY from the ignition.
- From a parked position remember to remove the PARKING BRAKE from the SET position before accelerating.
- NO ALCOHOLIC BEVERAGES PERMITTED IN VEHICLES except for closed containers during transport for commercial delivery purposes.
- Vehicles will be driven in a slow and careful manner and remember to YIELD TO PEDESTRIANS AT ALL TIMES.
- It is the below signatory's responsibility to obligate all users to this operating policy.
- **It is the requesting company's responsibility to ensure proper installation of all golf cart permits. A \$200.00 plus shipping replacement fee will be charged for any replacement credentials.**

ANY INJURIES INVOLVING VEHICLES WILL BE REPORTED TO AMERICROWN AND/OR RACETRACK FACILITY REPRESENTATIVES AND YOUR DIRECT SUPERVISOR

Use of golf Vehicles is a privilege and anyone found in violation of these guidelines or operating in such a manner deemed to cause harm to themselves or others will be subject to impounding of the Vehicle and revocation of permit and driving privileges. Leaving the scene of an injury involving a vehicle will result in revocation and ejection from the property.

I agree to release, hold harmless, indemnify and defend Americrown Service, LLC, its respective parents, subsidiaries, limited liability and affiliate companies, and their respective members, shareholders, officers, directors, agents, employees, sponsors, trustees, receivers, successors, and assigns, the City of Homestead, the Daytona Beach Racing & Recreational Facilities District, City of Daytona Beach, and County of Volusia (collectively the "Indemnified Parties") from any and all liability or damages including reasonable attorney fees arising from injuries to person(s) or damage to property which may arise from the use of these Vehicles by the company named below, its employees, agents or representatives. My obligations hereunder to defend shall extend to claims alleging sole negligence, willful misconduct or violation of law of an Indemnified Party when combined with other claims triggering my obligation to indemnify, provided however that upon final adjudication by a court of competent jurisdiction or written settlement between the parties, I will be reimbursed for the portion of fees or losses so adjudicated as the responsibility of an Indemnified Party. I acknowledge that the Indemnified Parties do not accept any responsibility or liability by virtue of registering vehicles.
